OFFICE ORDER

In continuation of earlier advisory on Novel Coronavirus (COVID19) dated 14th March, 2020 of ITAT, Bangalore Benches, Bangalore and Office order dated 16th March, 2020, of Hon'ble President, ITAT and in view of the lockdown of Bangalore from 20th March, 2020 till 31st March, 2020 announced by the Karanataka Government for prevention and containment of COVID 19 resulting in the sealing of Bangalore borders with neighbouring states and affecting majority of public transport and complete shutdown of Bangalore Metro, it has been decided to take following further precautionary measures at all Benches falling under the Bangalore Zone:

- (i) That the hearing of all regular matters/appeals (INCLUDING Stay Granted matters) old appeals etc. at all benches of Bangalore zone till 31st March, 2020 or until further orders, whichever is earlier shall stand adjourned and the next date of hearing shall be notified on the website of ITAT.
