In exercise of the powers conferred to the Vice Presidents, ITAT, by the Hon'ble President, ITAT in consonance with order dated 22.03.2020 of the Hon'ble Supreme Court of India to restrain the spread of Novel Corona Virus (Covid 19) and In view of the Order File No. F-2071/F-II(6)-2020/5000-5002 dated 22.03.2020 issued by the Health Department, Chandigarh Administration notifying a lock down in the territorial jurisdiction of the entire U.T. of Chandigarh and similar situation of complete lockdown in the States of Haryana, Himachal Pradesh, Rajasthan and Punjab, affecting means of all Public Transport, the following directions for all the Benches falling under ITAT, Chandigarh Zone are issued:


